- outperformed local district by increasing margins (17 pts, 22 pts, 28 pts)
- has the 5th highest percentage of English Language Learners of all schools in the state, and met OLEPA goals
- one of very few urban schools that met expectations in K-3 Literacy

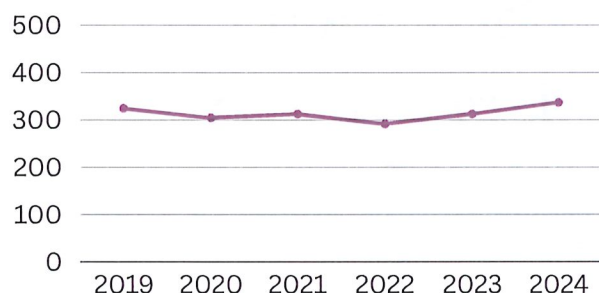

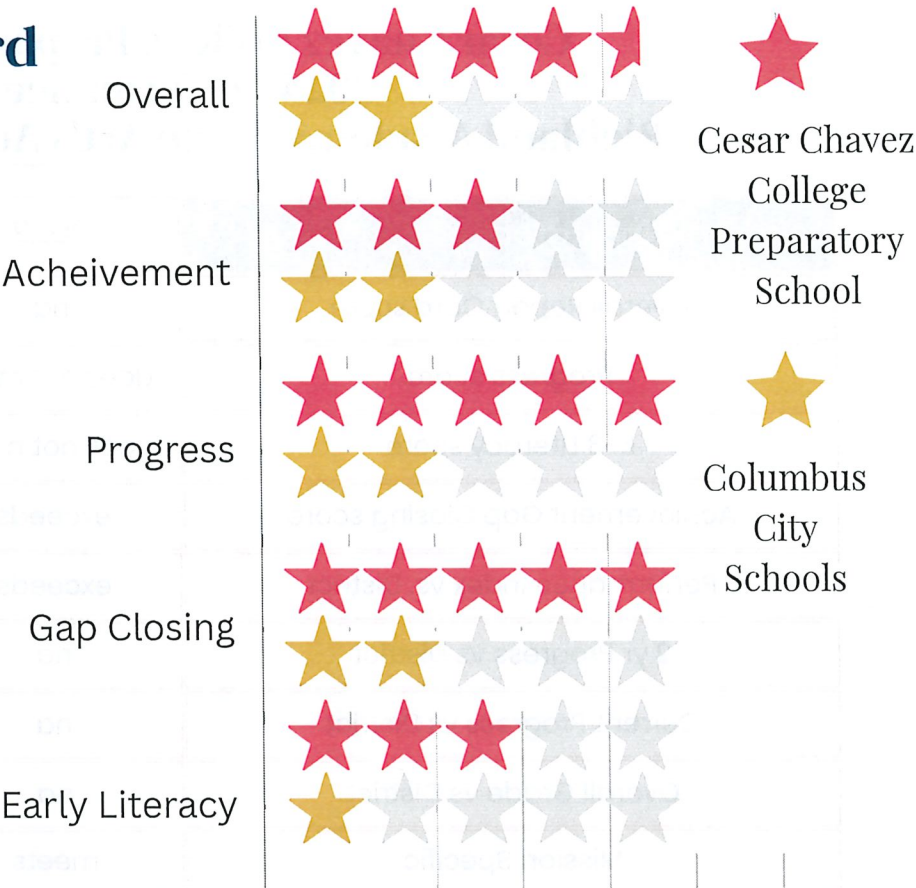

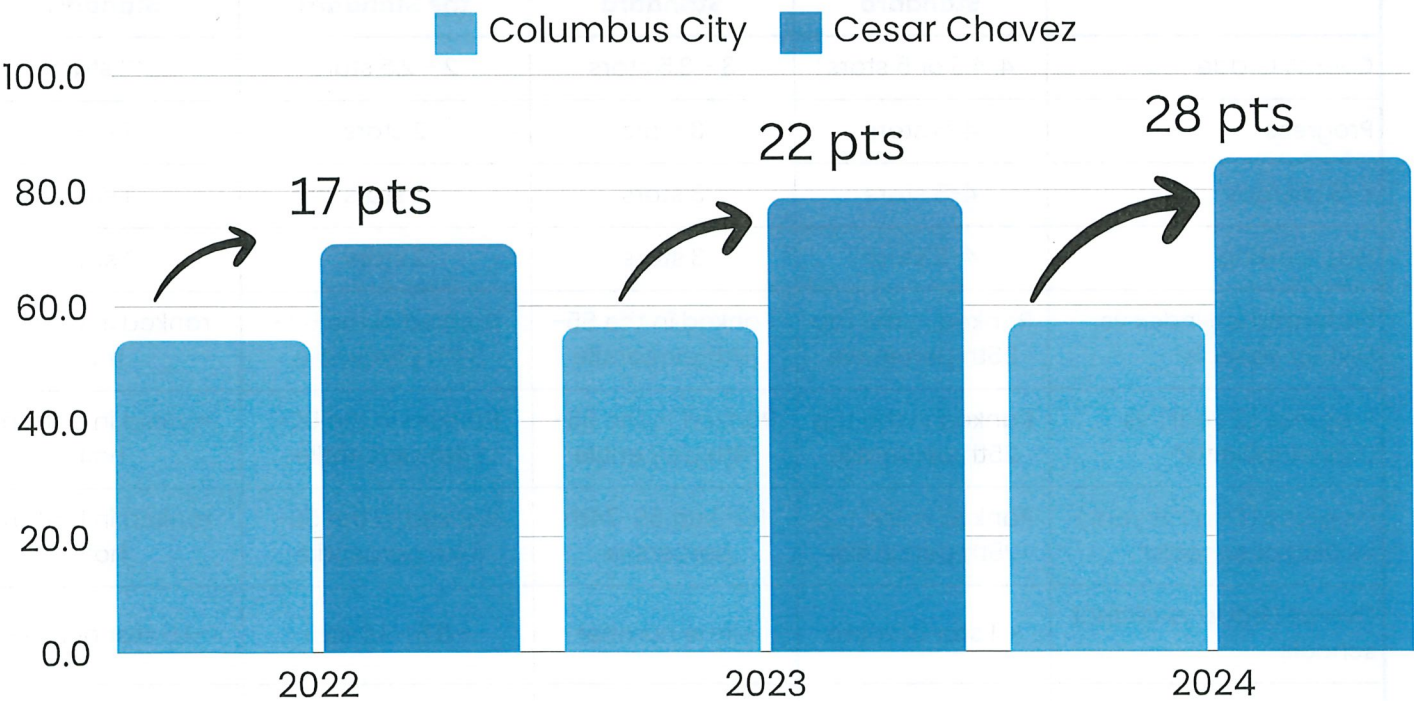


## Cesar Chavez College Preparatory School compared to Columbus City Schools District
